

# SCAQ Professional Pathways Program Subscription Terms and Conditions – 19 June 2026

## 1. Purpose

This policy exists to guide SCAQ staff, Committee Members, Board Members, SCAQ Members and employees of SCAQ

Members on the use and conditions for use of the SCAQ Professional Pathways Program Subscription Package.

The following terms and conditions are applicable to all products covered under the SCAQ Professional Pathways Program Subscription Package.

## 2. SCAQ Professional Pathways Program Subscription

The SCAQ Professional Pathways Program Subscription includes all live CPD webinars and On Demand SCAQ CPD Webinars through the Education Platform.

## 3. Purchasing the SCAQ Professional Pathways Program Subscription Package

Corporate members can purchase the SCAQ Professional Pathways Program Subscription Package with their membership renewal. The cost of the package is for a 12-month period and is based on the number of lots under management as of 30th June each year.

Corporate members can also purchase the SCAQ Professional Pathways Program Subscription throughout the year. The cost of the package is based on the number of lots under management at the time the application is made and will be pro-rated.

## 4. Inclusions

The SCAQ Professional Pathways Program Subscription is available to all employees of the purchasing Corporate SCAQ member.

The registrant is not required to be a member of SCAQ if the corporate entity is a member of SCAQ and has purchased the SCAQ Professional Pathways Program Subscription, however confirmation that they are an employee of the corporate member will be required at the time of registration.

As of 1 July 2023, access is also available to the Education Platform enabling employees of the corporate member to download and view SCAQ CPD webinars On Demand.

The SCAQ Professional Pathways Program Subscription entitles members to 10% discount on standard registration prices to package exclusions, but is not able to be claimed with any other discount.

## 5. Exclusions

The SCAQ Professional Pathways Program Subscription excludes the following:

## **7. Payment terms**

The payment policy applies to all members of SCAQ. SCAQ's standard payment terms are 14 days, unless otherwise stated.

## **9. Registration for Live Webinars**

Live Webinars: Unless your company has an SCAQ Professional Pathways Program Subscription Package, screen sharing, and link sharing is NOT permitted.

SCAQ is electronically advised every time a Zoom/Teams link is shared and with whom.

SCAQ reserves the right to invoice additional attendees, post webinar, if the link has been shared to individuals that were not registered to attend and are not on the SCAQ Unlimited CPD Webinar Package.

a. If you are an employee of an SCAQ Corporate Member who has purchased the SCAQ Professional Pathways Program Subscription Package, you can access the live webinars and SCAQ On Demand webinars for FREE.

b. If the registrant is an employee of a Corporate Member and the Corporate Member has not purchased the SCAQ Professional Pathways Program Subscription Package, they will be charged at the current Member rate for CPD webinars

c. If the registrant is not a member of SCAQ, they will be charged the non-member rate per CPD webinar. Please refer to the webinar registration for pricing.

d. ## **10. On Demand:**

The administrator of the Company will be responsible for advising their current employees of the code.

SCAQ is electronically advised every time On Demand Content is accessed.

SCAQ reserves the right to invoice registrants of the On Demand Content, if the code has been:

a. shared to individuals that are not on the SCAQ Professional Pathways Program Subscription Package as per '8' above. used by individuals that are no longer employees of the company with the SCAQ Professional Pathways Program Subscription Package. incorrectly applied to content that is excluded from the SCAQ Unlimited CPD Webinar Package. As per '5' above.

**Fees that will be incurred for incorrect use of the code:**

b. If the registrant is an employee of a Corporate Member and the Corporate Member has not purchased the Professional Pathways Program Subscription Package, they will be charged a member or non member fee for the CPD webinar.
